#### **TUMUT SHIRE COUNCIL**

#### **CHIT CHAT COFFEE SHOPPE**

I have recently been diagnosed with cancer and have experienced great difficulty accessing and affording some of the medical treatment I need. To access ultrasound I have had to travel out of town, an added cost and inconvenience as I have then to close my business for the day. Some of the costs involved with ultrasound have been \$275 and over \$300 which I have been required to pay in full at the time of service. If I were to have had these tests done in Canberra or Sydney, I would have been bulk billed and had the results within hours.

Although the staff at our local hospital have been terrific, it is obvious that we need a new hospital. Maternity has no privacy and is pressed for space. Also, there are no facilities for caesarian births. My daughter had to be transferred 100kms to Wagga Wagga for the birth of her baby. Electric beds are needed - when patients who cannot move need repositioning, they have to call a nurse for help, thus taking the nurse from other duties. If all beds were electric, the patients would have more independence and nurses would not have to be interrupted from other duties all the time.

I understood a new hospital was just around the corner. We need one now, not years down the track.

I feel that the South West Slopes has been a backwater as far as medical services and allied health is concerned extending from Gundagai to Tumbarumba, Tarcutta to Cabramurra. There is no obvious reason why this should be the case considering the progressive nature of the region. In particular the timber, manufacturing, horticulture and agriculture industries. When we are located halfway between Canberra and Wagga Wagga it seems strange that we can't harness technology to foster working relationships between these centres which would assist encouraging professionals into the region.

In addition, the state of the current hospital and community health facilities are certainly not assisting in attracting staff to work in Tumut, particularly in the allied health areas. Presently, as has been the case for some time, allied health workers, like their medical colleagues, are encouraged by remuneration and travel opportunities to seek employment overseas.

Improvements in the infrastructure, competitive salaries and development of services, in addition to better marketing of the region, could only help to persuade them to do otherwise. After all, those familiar with the area know that it has much to offer.

#### **TUMUT LIONS CLUB**

Whether a long term local resident or a recent arrival to Tumut, the availability or lack of adequate health services is something that is of the utmost importance to every community member. The Greater Southern Area Health Service (GSAHS) has responsibility for a huge area comprising many smaller towns as well as major centres such as Wagga Wagga and Albury, all with valid and competing interests in obtaining services. The financial problems besetting GSAHS, whether because of insufficient funding, mismanagement of funding, or a combination of both, do not inspire confidence that the needs of the Tumut community will be met, despite the work that has gone into the current Area Health Plan. Whilst it is important for preventative strategies to be put in place to promote good health, and for improvement in Community Health services, there nevertheless remains the issue of the antiquated facilities at Tumut Hospital which are far from what should be acceptable for the 21<sup>st</sup> Century. It should not be forgotten that Tumut is a centre that is not only working hard to attract business, but it is also a major holiday attraction on the route to the snowfields, and to the coastal resorts of the south coast.

The dedicated nursing staff should not have to put up with the inferior facilities and neither should the people of Tumut. It is time to reconsider funding priorities and to ensure that the community does not have to wait indefinitely for decent health facilities and a new hospital.
